Welcome to the Embassy Suites – Detroit Metro Airport

We are pleased that you have selected the Embassy Suites – Detroit Metro Airport.

We are committed to insuring that your visit is safe, comfortable and enjoyable.

Please take a moment to familiarize yourself with our rules and regulations and share them with your group.

NO BIRTHDAY OR CHILDREN’S PARTIES ARE ALLOWED IN GUEST ROOMS. Any rooms having a party will be asked to leave the hotel promptly without refund. Please inquire about banquet space with our Sales/Catering staff.

Due to state law and local fire ordinances, the maximum number of guests in a King suite is four (4) and in a Double suite is (6). Any non-registered guests found in a room will be required to leave immediately.

Noise or an activity that disrupts the normal tranquil atmosphere of the hotel is **NOT ALLOWED** and may result in **EVICTION** without refund.

Running in the hallways or stairwells, door slamming and yelling across the hallways will not be tolerated and may result in eviction from the property.

YOU MUST BE 21 YEARS OF AGE TO RENT GUEST ROOMS and must be present in the guest room(s) for the durations of the visit. Every room must have an adult.

The registered guest(s) of each room is responsible for the behavior and actions of anyone visiting their room and must insure that their visitors abide by all hotel rules and regulations.

Physical damage to the property will result in additional charges to the registered guest based on the nature of the damage and cost to repair.

Children under the age of eighteen (18) not accompanied by an adult while in the public areas of the hotel will be escorted back to their room.

Curfew for all children under the age of eighteen (18) is 10:00pm. There are no exceptions.

The pool and exercise area is for the use of registered guests only. Children under the age of eighteen (18) must be accompanied by an adult at all times in the pool area.

Group gatherings in guest hallways are a violation of local fire codes.

Due to state licensing laws, food and beverage items personally brought into the hotel may not be consumed on the first floor or public areas.

Due to our Michigan Liquor License, alcohol that is **NOT** purchased from one of our food & beverage outlets (Eighty Six Hundred Lounge or the e-Port Café) may **NOT** be consumed on the first floor or any public areas of the hotel. Alcohol brought into the hotel must be contained to your suite.

Due to Michigan Gaming Law, there is no card playing or any other gaming activity on the first floor/public areas of the hotel. This applies whether any monetary value is involved or not.

NO HOCKEY STICKS, PUCKS, MINI-SHINI STICKS, BALLS, BATS, FRISBEES are allowed in the hotel. Violation of this rule may result in eviction without refund.

This policy and its strict enforcement are our way of insuring an enjoyable visit for all guests of the hotel. We are strongly supported by the Romulus Police Department in doing our part to protect our guests, employees and assets. By signing this agreement you are hereby stating that you are the registered adult in the room, you are responsible for all guests in your room, and you agree to abide by all rules and regulations listed above.
