REQUEST FOR TENDER Minor Hockey Uniform

1. INTRODUCTION

Kent Minor Hockey Association is seeking tenders from qualified suppliers for the provision of hockey uniforms. This tender covers House League (HL) uniforms, Local league (LL) uniforms, Select uniforms and Representative (Rep) team uniforms. Suppliers may submit a tender for one or more of the categories outlined in the Scope of Work.

2. CONTRACT

This tender is for a 1 year commitment with the option to extend for an additional 2 seasons.

3. SCOPE OF WORK The successful supplier will be responsible for providing:

- House League (HL) uniforms
 - 12 sets of uniforms in total
 - U13, U15, U21 17 player & 2 goalie uniforms per team
 - HL uniforms to include: Kobe tryout jersey and knit socks
 - Jerseys are screen pressed with logo on front and number and stop sign on back
- · Local League (LL) uniforms
 - 2 sets of uniforms for U18 division. 17 player & 2 goalie uniforms per team
 - LL uniforms to include: Kobe tryout jersey and knit socks
 - Jerseys are screen pressed with logo on front and number and stop sign on back
- Representative (Rep)/Select team uniforms & try-out jerseys
 - Provide Kobe tryout jerseys in KMHA colour to be available at Spring tryouts (date to be determined)
 - Rep uniforms to include: sublimated jerseys, sublimated socks (home & away)
 - Select uniforms to include: sublimated jerseys, knit socks (home & away)
 - Rough number of Rep uniforms to be ordered 14 teams of 17 players + 2 goalies
 - Rough number of Select uniforms to be ordered 4 teams of 17 players + 2 goalies

4. DELIVERY REQUIREMENTS

All uniform orders must be delivered within six (6) weeks from the date of order confirmation. Delays beyond this timeframe may result in penalties or contract termination.

5. PRICING STRUCTURE

Suppliers must submit pricing for the following categories:

- House League (HL) & Local League (LL) uniforms (practice jersey and knit socks, per player)
- Select uniforms (home and away jerseys and knit socks, per player)
- Representative (Rep) uniforms (home and away jerseys and sublimated socks, per player)
- · All pricing must be submitted in CAD, including any applicable taxes and delivery charges

6. QUALITY AND SPECIFICATIONS

Uniforms must meet the following specifications:

- Durable, high-quality fabric suitable for hockey play
- · Custom team logo printing
- Compliance with official minor hockey standards (provided on successful tender)

7. SUBMISSION REQUIREMENTS

All tenders must include:

- · Any or all of the Scope of Work being applied for,
- Confirmed ability to meet the 6-week delivery requirement

8. EVALUATION CRITERIA

Tenders will be evaluated based on:

- Price competitiveness
- · Quality and durability of uniforms
- Delivery timeline compliance
- Supplier experience and references
